MICRO GRANTS

92 AWARDS TO DATE AT \$250-\$500

Support for capacitybuilding items(eg. supplies, research, travel, equipment/software, etc; one-time award

GENERATOR GRANTS

27 AWARDS TO DATE AT \$1,000-\$1,500

Support for curated group shows or similar collaborative work; further support from Amplify for promotional and network support and curatorial assistance

PUBLIC IMPACT GRANTS

5 AWARDS TO DATE at \$10,000 over 2 years

Provides funds/support to artists whose work processes civic engagement, community informed collaboration and creative problem solving to understand the complexities of systematic change

ARTIST SUPPORT GRANTS

12 AWARDS TO DATE AT \$5,000

Unrestricted money to enhance or improve artistic practice

THIS EVALUATION RESPONDS TO THE FOLLOWING QUESTIONS:

- 1) What has been the impact of Amplify Arts' grant support on individual artists in the Omaha metro area since the inception of the program 5 years ago?
- 2) How has Amplify Arts' Artist Grants program supported the development of a thriving arts ecosystem?

THE EVALUATION FINDS THAT:

Amplify Arts' grants support to individual artists has had a strong, consistent, positive effect at the individual and network levels.

Amplify Arts' Artist Grants Program has and continues to play a crucial role in supporting the development of a thriving arts ecosystem in Omaha. One mechanism for this is the *grant funding* to artists that Amplify Arts provides. Amplify Arts is among only a few organizations specifically focused on the Omaha arts ecosystem that also provides grant funding to artists. A role providing such funding may be especially important and relatively rare in Omaha.



About Omaha's Arts Ecosystem




To purchase supplies/equipment that directly supported my practice

FINDING:

Grant funds are most frequently used to make equipment purchases and compensate collaborators

33% used grant funds as a means to compensate other artists with whom the grantee was collaborating

All grant recipients reported that the grant and associated experiences made a positive impact at the personal and professional level

73%

REPORTED THE GRANT:

"Increased my belief in myself as an artist" 64%


REPORTED THE GRANT

"Reduced my stress (for example, by offsetting cost of living expenses and/or allowing me to focus on my work in a new way)" AND "Increased my visibility as an artist in the Omaha area"

These grants made me want to live in Omaha despite having no intentions of staying when I first moved here...


They made me want to stay not for the potential of more grants or support from Amplify/other orgs, but for the communities, places, and political projects they introduced me to and meaningfully integrated me into."

FINDING:

Grants other than Micro Grants were especially impactful in increasing artists' visibility in the Omaha area





At the network level, grants were especially impactful in affecting relationships among and between artists

67% reported grant funding supported relationship-building with other artists



Respondents saw positive, community level impacts from grants




"Increased adults' excitement about and understanding of the arts"

I think we have not figured out how to break down the borders of...segregation yet. And I know a lot of other places are very similar. But I think we still don't know how to invite-- outside of the leadership aspect—I think we don't know how to break down the barriers to invite other audience members and make our audiences more diverse as well. Because it's not just enough for you to be telling Black stories to a community where its majority of theater patrons are White. It's telling Black stories that also include Black audiences and Hispanic audiences and Middle Eastern audiences and Asian audiences."

FINDING: Lack of funding to artists is an issue in Omaha

As indicated by survey responses about growth areas for Omaha, a review of other cities' funding for the arts suggests that less funding to artists is available in Omaha than in these other locations.

RECOMMENDATIONS

It is recommended that Amplify Arts and other organizations and people seeking to develop a more sustainable, just, and thriving arts ecosystem for Omaha consider the following:

Increase funding to artists in Omaha.

Increase public support for the arts in Omaha.

Make the arts accessible for all audiences

Create opportunities and processes that put artists and artists' voices in a leadership position.

Build on the strengths of Omaha's arts ecosystem.

Evaluation Approach

This evaluation used a mixed methods sequential design. Specifically, this evaluation began with one-on-one, semi-structured interviews with current and former Amplify Arts grantees. Through these conversations and through exploratory, inductive content analysis of the data, categories were developed around:

- How grantees used grant funds;
- The difference made (if any) from grant funding at the individual, network, and community levels;
- The strengths and growth areas for Omaha's arts ecosystem; and
- What a thriving arts ecosystem for Omaha might look and sound like.

A survey was then fielded, with survey questions and responses framed in a way that was reflective of the categories that emerged from the initial interviews. A total of 68 survey responses were received; the overall response rate for the survey was 38%. Respondents included both grantees and other key partners such as arts administrator, philanthropists, donors and Amplify Arts board members. Also, language and wording from the interview conversations were used to craft survey questions and responses.
